Parents are asked to have a plan in place for their children's supervision and care in the events a school day is altered due to inclement weather or other emergencies.

Pre-School Developmental Screening

The School District of West De Pere offers developmental screening for preschool-aged children. The school district uses census data to mail out the Ages and Stages developmental questionnaires throughout the year, asking parents to complete the questionnaire and return it promptly by mail. As the questionnaires are returned, school professionals score them and provide written feedback to parents on the general developmental readiness of their child(ren). In certain circumstances, the school district will invite children to participate in an additional on-site screening. If you would like to request a developmental questionnaire, please call the Department of Student Services at (920) 337-1393 ext. 8012.

Five-Year-Old Kindergarten Registration

The School District of West De Pere held kindergarten registration for children who are planning to attend kindergarten in the fall of 2021. In case you missed it or your child does not attend our 4K program and you are planning on sending your child to kindergarten, please register your child as soon as possible at your school of residence: Hemlock Creek Elementary School, <u>1900 Williams</u> <u>Grant Dr, De Pere</u> or <u>Westwood</u> <u>Elementary School, 1155 Westwood</u> St, De Pere.

Children must turn five years of age on or before September 1, 2021 and live in the West De Pere School District to be eligible for the West De Pere kindergarten program. For registration, you will need to bring your child's birth certificate, proof of address, and immunization records. The child does not have to attend the registration. If you have any questions, please call (920) 425-1900 ext. 3320 for Hemlock Creek or (920) 337-1087 ext. 1320 for Westwood. **Open Enrollment** Wisconsin's public-school open enrollment program allows parents to apply for their children to attend school districts other than the one in which they live. For more information, please visit the open enrollment web site at: dpi.wi.gov/open-enrollment or call the district office at (920) 337-1393, extension 8025.

Census

The Census counts every person in the 50 states, District of Columbia and the five U.S. territories. The Census is mandated by the Constitution and the information will provide critical data for government officials, business owners, lawmakers and many others. Over \$765 billion in federal funding is allocated annually to hospitals, schools, fire departments, roads and other resources based on census data. Beginning in mid-March, households will receive an invitation to participate in the Census online, by phone or by paper. Help shape the future of our schools and community by filling out the Census. We need your help in planning for the future in the West De Pere School District. If you have not previously filled out our Census Form, you have just moved, or you are new to the District, please contact the District Office of West De Pere or your child's school to request one.

Who needs to be counted? Household members under the age of 21 who reside at a West De Pere School District address need to be recorded on our school census even if they do not attend or plan on attending West De Pere Public Schools. If you are living in the West De Pere School District and your child(ren) attend a private school or attend school in a different district than West De Pere, they still need to be counted on the school census of the district in which they reside.

How to complete the form-

- If you have children under the age of 21 who reside at a West De Pere School District address. Be sure to include any post office box or apartment number with the actual address of the residence.
- If there are no children under the age of 21 residing at a West De Pere school district address, please complete the address section on the form, indicate there are no children under the age of 21, and return the form. We will then remove your address from our records.

Helpful Information

Wisconsin Immunization Law

Any student admitted to any elementary, middle, junior, or senior high school shall, within 30 school days after the date on which the student is admitted, present written evidence to the school of having completed the first immunization for each vaccine required for the student's grade and being on schedule for the remainder of the basic and recall (booster) immunization series for mumps, measles, rubella (German measles), diphtheria, pertussis (whooping cough), poliomyelitis, tetanus, and other diseases that the department specifies by rule or shall present a written waiver. The immunization requirement is waived if the student, if an adult, or the student's parent, guardian, or legal custodian submits a written statement to the school objecting to the immunization for reasons of health, religion, or personal conviction. The student, if an adult, or the student's parent, quardian, or legal custodian shall keep the school informed of the student's compliance with the immunization schedule.

Hello and Welcome to West De Pere School District. I hope everyone had a great summer. If you would like to meet with me confidentially to discuss your student's health, please contact me by phone or e-mail. Just a few reminders to ensure the health and safety of all students:

<u>Please keep your student home if they are sick!</u> I know we all hoped that COVID would be a thing of the past but it is still here along with other common illnesses. If your student becomes ill during the school day, staff will use the following guidelines to determine if your student should be sent home:

- **COVID-19 or Influenza like Illness**—symptoms such as temperature of 100.4 F or greater, along with respiratory symptoms of cough, shortness of breath, runny nose, sore throat, headache, body aches, chills, nausea and vomiting, diarrhea, new loss of taste or smell and fatigue.
- Vomiting and diarrhea
- Contagious illnesses such as chicken pox, strep throat, "pink eye" conjunctivitis, impetigo, scabies, live head lice or other determined by healthcare provider
- Rashes of unknown origin

Medication needs at school:

- **Prescription** medication must have a physician's order to dispense medication at school and is completed annually. The prescription drug must be supplied by the student's parent or guardian in the original pharmacy-labeled package. The package must specify the student's name, the prescriber's name, the name of the drug, the dose, the route, the effective date and the directions in a legible format.
- Aerosol generating medication given with a Nebulizer will not be given routinely due to high risk of Covid-19. A nebulizer treatment will only be given on an emergency basis or if there is a medical documentation the student cannot do an inhaler.
- Over the counter/nonprescription medication requires parent or guardian consent and is completed annually. The nonprescription drug product must be supplied by the student's parent or guardian in the manufacturer's package and the package must list the ingredients and recommended therapeutic dose in a legible format. A student may be administered a nonprescription drug product in a dosage other than the recommended therapeutic dose only if the request to do so is accompanied by the written approval of the student's healthcare provider.
- Medication forms are now available on the School Nurse district web page or the school office.

All medications will be dispensed by designated office personnel. Phone instructions or hand-written notes will not be accepted to dispense medication at school. The West De Pere School District will not supply medication.

Emergency Action Plan, Individual Health Plan or Health Alert; This plan communicates with school staff specific medical needs your student may have in the school setting. Health plans must be updated annually and are completed with the school nurse. Please contact the school nurse if you feel your student needs a health plan at school.

Meningococcal disease is a rare, but potentially deadly, bacterial infection that can take the form of meningitis. Teenagers and college students are at risk for this disease due to lifestyle factors. Meningococcal bacteria are transmitted through air droplets and/or by direct contact with secretions from infected persons. Meningococcal disease is often misdiagnosed since symptoms are similar to those of common viral illnesses. Symptoms may include a high fever, severe headache, stiff neck, nausea, vomiting, sensitivity to light, confusion, exhaustion and/or a rash. The Center for Disease Control and Prevention (CDC) recommend routine vaccine immunization for 11-12 years old with a booster at age 16. Teens and young adults (16- 23 years old) also may be vaccinated.

This newsletter is a service provided to all residents of the School District of West De Pere. BUSSING AND TRANSPORTATION

Policy #3541

Students who are residents within the School District of West De Pere attendance boundaries are entitled to transportation provided by the school district if the following conditions apply:

- All students living two miles or more from the school they are required to attend will be transported.
- Students living less than two miles from the school they are required to attend will be transported if they are subjected to an "unusual hazard" area while walking to school. All students between 4K and 6th grade will be considered for bussing if they live in an area considered an "unusual hazard". Such "unusual hazard" must be consistent with School Board Policy 3541(R). These hazardous areas will be re-evaluated every five (5) years. Affected families will be advised in writing of any bussing change that is a result of this re-evaluation.
- Parents of students not eligible for district funded transportation may contract for such directly with the bus contractor.
- Beginning the 2017-2018 school year, all resident 4K students will be offered transportation to and from the school they attend.

Disabled Students

- (a) Pursuant to Wisconsin Statutes. transportation shall be provided to those students who reside within the school district and the students' IEP determines transportation to be a related service.
- (b) Disabled students will be transported on the regular buses if they are

- Whether the student's teachers as (a) met state qualification and licensing criteria for the grade levels and subject areas in which the teacher provides instruction, (b) is teaching under emergency or provisional status through which state qualification or licensing criteria have been waived, and (c) is teaching in the field of discipline of the certification of the teacher; and

able to get on and off the bus with little or no assistance and do not require any special care while on the bus.

- (c) The district will provide the necessary transportation for disabled students who cannot ride the regular school bus.
- (d) Every occupant shall be secured to the wheelchair while being transported. The securement shall be separate and in addition to securing the wheelchair to the bus. Belts securing the occupant to the wheelchair shall be the responsibility of the owner of the wheelchair, parent or guardian.

Policy #3545

In accordance with the West De Pere School Board policy 3545, please be advised of the following regarding video monitoring on school buses.

In an attempt to better regulate student behavior aboard contracted school buses, the district is utilizing equipment in the form of video monitoring devices on some of the buses. Buses with monitoring devices on board will have a notice displayed inside the bus near the camera.

TOBACCO/NICOTINE USE ON SCHOOL PREMISES Policy #1335

Tobacco and nicotine use are prohibited at all times on school premises. "School premises" include all property owned by, rented by or under the control of the School District of West De Pere.

Possession of tobacco or nicotine products by minors is prohibited.

The administrative staff shall inform students, staff and the general public about this policy and shall establish enforcement procedures.

For purposes of this policy, "Tobacco and nicotine use" means to chew or maintain any substance containing tobacco, including smokeless tobacco, in the mouth to derive the effects of tobacco, as well as all uses of tobacco, including cigars, cigarettes, pipe tobacco, chewing tobacco, snuff, any other matter or substances that contain tobacco or nicotine, in addition to papers used to roll cigarettes and/or the smoking of electronic, "vapor," or other substitute forms of cigarettes, clove cigarettes and any other lighted smoking devices for burning tobacco, nicotine, or any other substance.

DISTRICT RESIDENT REQUEST FOR

SCHOOL TRANSFER Policy #5007

District residents who request to transfer schools within the School District of West De Pere for the 2020-2021 school year are due <u>January 31, 2020</u>. Guidelines to the West De Pere policy #5007 are:

- 1. Only written requests will be considered.
- 2. Requests by district residents for school transfer shall be made in writing during the month of January. Requests received after January 31st may be considered if space is available. Applicants should submit their written request by completing the "District Resident Request for School Transfer" form. Written requests should be submitted to the school office. Final decisions will be made by the building principals. Parents/ guardians have the right to appeal decisions to the district office.

DRUG-FREE SCHOOLS Policy #1336

It shall be the policy of the School District of West De Pere to adopt and maintain drug free facilities and programs. As such, use or possession of illicit drugs and/or alcohol by students, staff, or citizens will not be tolerated and will be punished to the fullest extent of existing laws. Enforcement of this policy may include canine searches, breathalyzers, and/or undercover investigations.

The District will develop education, prevention, and assistance programs for both students and staff recognizing that punishment is not effective as a sole measure. The community will also be informed of the drugfree expectations via public notice and posting in appropriate places throughout district facilities.

The drug-free efforts and programs shall be evaluated as to the effectiveness of the program and enforcement of sanctions.

SCHOOL DISTRICT OF WEST DE PERE ANNUAL ASBESTOS NOTIFICATION

This notice has been written to comply with the Federal Environmental Protection Agency (EPA) Asbestos Hazard Emergency Response Act (AHERA) regulations requiring yearly notification of asbestos activities within the School District of West De Pere.

An Asbestos Management Plan was developed in 1988 and has been continually maintained and updated since that time. The Management Plan is available to anyone for viewing during normal business hours by appointment only, when such appointment is made with the designated person at least one working day in advance.

Abatement of asbestos containing building materials is performed when necessary by accredited persons prior to disturbance during scheduled renovation or construction projects.

SCHOOL DISTRICT OF WEST DE PERE ANNUAL INDOOR ENVIRONMENTAL QUALITY PLAN NOTICE

This notice has been written to comply with the Federal Environmental Protection Agency (EPA) and State of Wisconsin indoor environmental quality (IEQ) program.

An IEQ Management Plan was recently developed and adopted (July 2013) and will be continually maintained and updated. The Management Plan is available to anyone for viewing during normal business hours by appointment only, when such appointment is made with the designated person at least one working day in advance.

The IEQ program was developed to ensure appropriate indoor air quality within our school buildings in accordance with Wisconsin Statutes 118.075 (3) and (4), indoor environmental quality (IEQ) in schools.

ELECTRONIC COMMUNICATION DEVICES

Policy 5130 (Reference: 1989 Wisconsin Act 120, Wisc. Stats. 118.258)

It is the policy of the School District of West De Pere that students who possess an electronic communication device during the school day will be required to keep the device off should the administration have determined that the device has become a disruption in the school setting.

Electronic recording devices are prohibited from use and display while in district facilities or while in attendance at district sponsored activities in places where others have a reasonable expectation of privacy to include, but not limited to, locker rooms, shower rooms, restrooms.

If a device is confiscated for disruptive use, it will be held by school officials for return to parent(s)/guardian(s) of the student, retained for disciplinary reasons, or turned over to law enforcement officers. Students will be disciplined in accordance with procedures specified in relevant District policies, school handbooks, and State and Federal Statutes.

Use or possession of an electronic device is allowed if the school board or its designee determines that the device is used or possessed for medical, school, educational, vocational, or other legitimate use.

Students violating this policy may be subject to suspension, expulsion, or other penalties. Students shall be informed of this policy through publication in the student handbook.
