In connection with and consideration of my participation on School premises and/or School sponsored activities, I, hereby represent and agree as follows:

- 1. - 3. I further agree to reimburse or make good any loss or damage cost that the school (its officers, employees and agents) may have to pay if any litigation arises on account of any claim made by me or anyone on my behalf.

Knowing the dangers, hazards and risks associated with the School and the specified activity and with sufficient knowledge of my physical condition(s) and limitations, if any, I voluntarily assume all responsibility and risk of loss, damage, illness and/or injury to person or property which I may, in any way, sustain in connection with participation in the School, on the School premises and related activities.
- 5. I agree that I will abide by all rules and regulations applicable to participation in the run activity or any other events with or involving the School. I agree that the School, the School's staff, or other person or entity involved in any way has no duty to provide medical services should I require emergency medical treatment or first aid as a result of illness or injury associated with the School or related and/or specified activities.

To the fullest extent permitted by law, I hereby release and forever discharge, and agree not to sue and to indemnify and hold harmless, Hemlock Creek Elementary School and the School District of West De Pere, De Pere, WI and their governing boards, officers, agents, employees and volunteers from and against any and all liabilities, claims, demands and causes of action of any kind, including litigation expenses and attorney's fees on account of any loss, damage, illness or injury to person or property in any way arising out of or relating to my participation in or on Hemlock Creek Elementary School, other School District of West De Pere school premises, and/or involving School sponsored activities whether due to the negligence, mistake or other action or inaction of the School, the School's staff, or other person or entity involved in any way with the School.
