- I. Call to Order by President Melissa Bushmaker. Mission read. Introductions done.

## III. Reports

- a. President's Report
  - i. Bylaws updates. Skylar looked at the bylaws. Melissa made some changes that need to be officially approved. These were:
    - 1. Option of a co-president in addition to the addition of Vice President. Added officers may be elected to more than one term, but not more than 3 terms for any given position.
    - 2. Also, bylaws state officer nominations are supposed to be posted in Tuesday Notes with nominations done at the October meeting.
    - 3. Bylaws state regular expenses under \$50 can be paid by the board without being reported or voted. Changed to \$100.
    - 4. Kristi made a motion to approve the above changes to the bylaws. Patti seconded. All approved.

- V. New Business
  - a. Scholarship Fund (Jackie). Jackie.
    - i. Discussed more about the idea of a scholarship fund for using the excess money in a PTO account. These would benefit kids (Westwood kids only) to use towards AP/college credits at high school. Melissa suggested we look at doing an endowment fund and putting \$20,000 towards it. We would need to form a committee, have a panel, and have an application process. We would give up to \$2,000/year and assuming no money goes in and that only comes out, it will last for 10 years. Applications would be done in Spring to pay for classes in fall.
    - ii. Melissa is looking into what all needs to be done. Jackie is also reaching out to someone to gather more information. Jackie and Melissa will present at the next meeting.
    - iii. PTO in agreement we want to do a Westwood scholarship. Details to be ironed out.
